

### COMMITTEE REPORTS

Mr. Banach reported that big game hunting season is upon them, be careful and be safe.

Mr. Paddock reported that relative to the Communications project, he got a text from Sheriff Spike that they had started at the Sherman Tower to install land mobile radio equipment, which would be the Motorola contract. On Friday, the shelters were set at Dundee and Italy Hill, so it's making progress.

Dr. Cutler reported that they were forwarded the preliminary survey for the Farmland Protection Plan. He just wanted to caution everybody, that's not the final survey, that survey won't be finalized until the end of the week, and he's sure they'll get a copy of it at that point.

Ms. Flynn reported that this is just a reminder that the public hearing, for the 2023 budget will be this Thursday night at six o'clock. Right here in the Chamber and the tentative budget levy is fifteen point nine million. It's a six hundred thousand dollars decrease from the budgets in 2022, 2021, and 2020. Those were all flat levies, and that equates to a fifty-five cent per thousand tax rate reduction.

### PUBLIC COMMENT

Alex Andrasik stated that he is there representing the Finger Lakes Justice Partnership, and he's got two things that he wanted to bring up today. First, he was wondering why there's still a Constitutional County section on the Legislature website. He noticed that no other issue or topic or committee gets its own section with a heading in the main menu of the Legislature website and certainly not one that has been firmly rejected by the people of this county. He respectfully asks that the page be removed from the Legislature site. Second, reviewing the minutes from last month's meeting, he saw that a member of this body reported on a conference session about issues relating to diversity, equity, and inclusion, and refer to some of the concepts discussed as buzzwords. He thinks this is an opportunity to build greater understanding. He would like every member of this body to learn and appreciate that people who use terms like gender discrimination and white privilege are not using them as buzzwords, but rather expressions of theirs or others, everyday lived experiences. They're documented reality with real causes, effects, and consequences. To refer to them as buzzwords, regardless of whether they understand them or not, is dismissive of their reality, and betrays the possibility of not being truly invested in figuring the movement out as that legislature indicated. On the other hand, there are true buzzwords in the mixed terms that have essentially no valid meaning, no reflection, in reality, at least in the way they are used for political advantage, such as woke, in the way that they're used by partisan talking heads to muddy the waters of the discourse. English Justice Partnership would like to invite this entire body and everyone present to engage in a very serious conversation, with this topic in the interest of helping everyone to understand it better. He would like their email address to be in the minutes, so that it's available for everyone to refer to, <u>flxjustice21@gmail.com</u>. So that each member of the legislature can get in touch with them to have these important conversations in the interest of clearing up anything about the issues that don't make sense to them, that they are not understanding, that they have questions about, and if they don't hear from them, then they will plan to reach out.

Mr. Killen asked if Alex could clarify his opposition to support for the Constitution. He would take issue with his assertion that a large majority of the people in the County of Yates are somehow opposed to support for the Constitution. When it came to the discussions on the constitutional county, it was because there were some very distinct attempts by their State Government, which has been overturned by court proceedings and an attack on their second amendment. He talked to a lot of people in the County, and he thinks he got a fairly good read on where a lot of people stand on things like issues with the Constitution and he would love to hear the understanding, why people are very upset about support for the Constitution and all of the elements of it.

Alex replied that he talked to a lot of people in the county, too, and there's a lot of things going on beyond just the second amendment, as you know, in the Constitution, and he's not prepared to discuss that right now. He's just interested in knowing why, there was still a

section for that on the website, when that is not, as far as he knows, still under consideration. Let it be known, of course, that opposition to the Constitutional county proposal is a very specific thing, and separate from opposition to the Constitution, and he hopes that is clear to everyone.

WHEREAS, a Public Hearing was duly held on November 14, 2022;

NOW, THEREFORE, BE IT RESOLVED, that proposed Local Law 7-2022 entitled "A Local Law Establishing Residency requirements for Yates County Deputy Sheriff's" is hereby adopted; and be it further

RESOLVED, that a copy of this resolution be given to the County Attorney and the New York State Department of State.

### LOCAL LAW NO. 7 OF THE YEAR 2022

### **ENTITLED:**

# A LOCAL LAW ESTABLISHING RESIDENCY REQUIREMENTS FOR YATES COUNTY DEPUTY SHERIFF

BE IT ENACTED, by the County of Yates Legislature as follows:

### **SECTION 1 Title**

This Local Law shall be known as ESTABLISHING RESIDENCY REQUIREMENTS FOR YATES COUNTY DEPUTY SHERIFFS

### **SECTION 2 Purpose**

This Local Law established residency requirements for appointed Yates County Deputy Sheriffs (County Police Officers) as this Legislature recognizes the need to retain qualified and experienced police officers, and that it is occasionally necessary to employ individuals that do not reside within the County of Yates, but that reside in close proximity, determined to be five (5) miles. Therefore the Legislature elects to supersede certain provisions of Section 3 of the Public Officers Law of the State of New York to the extent it is restrictive in residency

qualification for holding the Deputy Sheriff office within Yates County, and adopt exceptions for certain towns in certain counties contiguous to the County of Yates.

### **SECTION 3 Exemption**

An individual appointed as a Deputy Sheriff by the Sheriff of Yates County shall at the time of his appointment or employment be a resident of the State of New York, and the County of Yates, or in certain Towns of certain counties contiguous to, five (5) miles of the Yates County boarder. Specifically for Ontario County the Towns of Naples, Gorham, Seneca, or Geneva excluding any city. For Schuyler County the Towns of Tyrone and Reading. For Steuben County the Towns of Pulteney, Prattsburgh and Wayne.

### **SECTION 4 Effective date**

This local law shall be effective upon its filing in the office of the Secretary of State pursuant to the Municipal Home Rule Law Section 27.

Mr. Killen stated that he just wants to stress the need for making sure they have housing for these ambulances they are looking to purchase as part of this. It's a big concern, he knows that they had some discussions about a couple of options. He is in favor of this and sees the need for this, but he is also still concerned about jumping in fully with both feet, as opposed to staging in going forward with it.

Mr. Willson stated that at the town of Potter meeting, they expressed general support of this. There are issues going back and forth with coverage of the area. Everybody is looking forward to it and hopes that it works out well.

### AUTHORIZE CHAIRWOMAN TO SIGN AUTHORIZATION FOR YATES COUNTY EMERGENCY SERVICES TO APPLY FOR A MUNICIPAL CERTIFICATE OF NEED AND ESTABLISH AN AMBULANCE SERVICE

WHEREAS, the furnishing of medical assistance in an emergency is a matter of vital concern affecting the public health, safety and welfare, prehospital emergency medical care, the provision of prompt and effective communication, and safe and effective care and transportation of the sick and injured being an expected public health service; and

WHEREAS, a county may provide an emergency medical service, a general ambulance service or a combination of such services for the purpose of providing prehospital emergency medical treatment or transporting sick or injured person found within the boundaries of the municipality or the municipalities; and

WHEREAS, a county acting through its local legislative body, may adopt and amend local laws, ordinances, or resolutions to establish and operate advanced life support first responder services or municipal ambulance service within a municipality, upon meeting or exceeding all standards set by the New York State Department of Health, Bureau of Emergency

Medical Services and Trauma Systems for training, staffing and equipment, and upon filing a written request for such authorization with the State Emergency Medical Services Council; and

WHEREAS, as an alternative to providing its own ambulance service, or in addition thereto, Yates County and its municipalities have relied on other organizations, associations or individuals, having sufficiently trained and experienced personnel, for the operation, maintenance and repair of, or to supply, staff and equipment, emergency medical service or ambulance vehicles, and for the furnishing of prehospital emergency treatment; and

WHEREAS, over time and for various reasons, fewer volunteers to staff this critical and expected service have been available to answers these requests, and it is anticipated that the decline will only continue, thereby leaving a significant part of the county without direct emergency services coverage, and placing a significant strain on the other parts of the system; and

WHEREAS, county officials, having met with one or more existing not for profit volunteer ambulance services, have determined that current existing entities within the county continue to have difficulty maintaining sufficiently trained and experienced personnel to provide adequate ambulance coverage within Yates County, and to regularly meet the generally accepted rural ambulance response standards, and the parties are currently unable to develop the synergies necessary to solve the EMS crisis;

NOW, THEREFORE, BE IT RESOLVED, that pursuant to Article 30 of the New York State Public Health Law, Section 3008, the Yates County Legislature hereby finds and determines that there is a demonstrated absence, reduced availability or inadequate level of care in ambulance or emergency medical service available to the County of Yates, which is not readily correctable through the relocation or improvement of existing services; and be it further

RESOLVED, that Yates County Emergency Services, with such assistance as might be required from other County departments deemed necessary and appropriate, are authorized and directed to apply for and obtain a Municipal Certificate of Need for an Advanced Life Support ambulance service, and commence operation effective June 11, 2023; and be it further

CONSIDERATION OF LOCAL ZONING EXEMPTION IN REGARD TO PROPOSED MODIFICATION OF EXISTING COMMUNICATIONS TOWER SITE IN THE TOWN OF MIDDLESEX, COUNTY OF YATES, STATE OF NEW YORK

WHEREAS, Yates County (the "County") commissioned a public safety communications study in 2019 and received a Public Safety Systems Communications Study Recommendations Report (the "Report") in 2020; and

WHEREAS, as a result of the study, Report and subsequent engineering investigations, the County determined to install a new public safety communications system which included the construction of four (4) new emergency communication towers to be located in the Towns of Barrington, Italy and Jerusalem and the Village of Penn Yan (the "Project"); and

WHEREAS, the County has further determined that the Project should be altered to also include the modification of an existing emergency communications tower located in the Town of Middlesex; and

WHEREAS, the modification will further improve emergency communication services and facilitate the provision of emergency services by police, fire, EMS and public works personnel for the benefit of all County residents; and

WHEREAS, the County wishes to ascertain whether its modification of the emergency communications tower is exempt from local regulations; and

WHEREAS, the local regulations being considered herein are namely the Town of Middlesex Zoning Laws and amendments (collectively, the "Local Regulations"); and

WHEREAS, in order to ascertain the same, the County wishes to apply the "balancing of interests test" established in <u>Matter of County of Monroe v. City of Rochester</u>, 72 NY2d 338 (1988);

NOW, THEREFORE, BE IT RESOLVED, that the Yates County Legislature makes the following findings with respect to the foregoing issue and each of the factors contained in the aforementioned "balancing of interests test":

- 1) The nature and scope of the instrumentality seeking immunity: The County is a municipal corporation, which through its offices and departments, coordinates the communications within the County of various government departments providing services that benefit the public.
- 2) The encroaching government's legislative grant of authority: The County is permitted and expected to provide adequate communications to enable municipal offices and departments to service the public interest; including but not limited to: law enforcement, fire, emergency medical, emergency management and highway services.
- 3) The kind of function or land use involved: The provision of adequate coverage to service the public interest communications needs within the County. To this end, on the existing emergency communications tower located in the Town of Middlesex the County wishes to modify said communications tower, and construct and operate those improvements necessary to support the modification and operation of said tower, as well as place the necessary associated utilities thereon.
- 4) The effect local land use regulation would have upon the enterprise concerned: Upon information and belief, the Local Regulations contain various requirements concerning the installation and operation of communications towers.

- 5) Alternative locations for the facility in less restrictive zoning areas: Upon investigation and evaluation of possible locations, the existing tower location is the County's best alternative for the placement and operation of its own communications tower in the Town of Middlesex. To this end, the existing tower is at a high enough elevation to ensure improved radio coverage with the modification, and is cost effective when compared to the development of other potential sites.
- 6) The impact upon legitimate local interests: Communications towers are not uncommon in the County as a whole. Any impacts, if at all, are minimal compared to the need for adequate communications benefitting the public.
- 7) Alternative methods of providing the proposed improvement: The County has investigated alternative methods for achieving the desired height required, and for the reasons set forth in Section (5) above determines that the existing location is the best location for the modified communications tower.
- 8) The extent of the public interest to be served by the improvements: The modified communications tower at its current location would greatly benefit the public interest, by way of its enhancements to communications to allow for the proper rendering of the following services, all of which are vital to the public-at-large: law enforcement, fire, emergency medical, emergency management and highway, as well as inter-operability with regional radios of other counties regarding such services. The County will use the modified tower to dispatch, receive and coordinate these vital communications. These important public needs outweigh any other impact identified with the construction and operation of the proposed site.
- <u>Intergovernmental participation in the project development process and an</u> opportunity to be heard: The Town of Middlesex was verbally made aware by the County of its intention to modify an existing communications tower at its current location. Via letter dated October 12, 2022 to the Town of Middlesex the Town was put on written notice by the Yates County Attorney of the Project and the County's intention to consider the issue of whether the Project is exempt from the Local Regulations, with such consideration to be done by way of application of the "balancing of interests test" established in Matter of County of Monroe v. City of Rochester, 72 NY2d 338 (1988). Moreover, pursuant to said letter, the County invited any and all comments and/or questions from the Town of Middlesex regarding the planned project and the project's process of development; it being the intention of the County to keep the Town continually informed and give the Town an opportunity to be heard; with the request that the Town provide any comments or questions prior to November 8, 2022. Furthermore, the Town was notified by the County Attorney of the applicable committee and full legislature meeting dates wherein the "balancing of interests tests" would be applied, wherein Town representatives are welcome to attend and be heard on the issue at such meeting(s). Comments and questions presented by Town of Middlesex legal counsel were addressed as part of the legislature's Public Safety Committee meeting on November 8, 2022; and be it further

RESOLVED, that the Yates County Legislature hereby finds that the balancing of interests analysis weighs in favor of the planned Project and its process of development, all as more particularly described herein, being exempt from the Local Regulations; and be it further

RESOLVED, that a copy of this resolution be forwarded to the Town of Middlesex. VOTE: Unanimous

Colby stated that they have a two day managers meeting in Syracuse on December thirteenth and fourteenth. So that's certainly going to be a topic of discussion there, so he will have an update after that.

Mr. Paddock stated that there were some changes to environmental conservation law, and in what he gave them, there were changes to lots of different laws, but will the Encon employee association be consulted when changes are proposed also, or any of the other laws.

Colby stated that he will ask those questions.

Mr. Paddock stated that this group got together and went through and changed a lot of laws without a lot of consultation, which is kind of the way things are done in Albany, but some of the changes just from his perspective didn't make any sense.

Colby stated that one of the comments from one of the lead people was tha legislators don't look at anything unless it's legislation to be changed, and they disagreed with them heavily. That they can have discussions with legislators and get through to them.

Chairwoman Church thinks they would like to formulate some response to it, and maybe they can consult on how that should be, and maybe the one from Genesee County is helpful.

# AUTHORIZE COMMISSIONER OF SOCIAL SERVICES TO CREATE AND FILL CASEWORKER POSITION

WHEREAS, the Commissioner of Social Services has requested to create and fill a fulltime Caseworker position due to a steady increase to our employees caseload that is becoming increasingly unmanageable; and

WHEREAS, the Commissioner has identified the need to create and fill a Caseworker position to ensure the needs of our community are met and to protect the individuals we support and serve; and

WHEREAS, the estimated annual cost to fill the position, including fringe, is \$64,294 to \$88,223, depending on health insurance; the County receives 80% reimbursement for salary and fringe and therefore the total cost to the County to create and fill this position will be \$12,859 to \$17,645; and

WHEREAS, the Commissioner of Social Services has requested authorization to start the candidate at either STEP one (1) or STEP two (2) of the current CSEA CBA Salary Schedule, should the candidate meet the eligibility for a higher starting rate of pay, and therefore, the estimated annual cost to fill the newly created position including fringe shall not exceed, \$67,397 to \$91,326; with the 80% reimbursement for salary and fringe, the total cost to the County to create and fill the position shall not exceed \$13,479 to \$18,265;

NOW, THEREFORE, BE IT RESOLVED, that effective November 14, 2022 the Commissioner of Social Services is hereby authorized to create and fill a full-time Caseworker position; and be it further

RESOLVED, that the Commissioner of Social Services is also authorized to fill any subsequent vacancy that will occur as the result of a promotion of an employee into the Caseworker position; and be it further

RESOLVED, that copies of this resolution shall be provided the Commissioner of Social Services, Personnel Officer, County Administrator, and Director of Finance.

# ENTER INTO AGREEMENTS WITH YATES COUNTY MUNICIPALITIES TO OBTAIN WORK PERMITS FOR THE RECONNECT PROJECT

WHEREAS, Yates County (hereinafter referred to as "County") has been awarded a USDA ReConnect grant to enable design and construction of a fiber-to-the premises broadband network to reach the unserved with regard to internet access; and

WHEREAS, the network design includes work to be performed in nearly every village and town in the county; and

WHEREAS, every village and town has its own unique permitting requirements including a mix of required documentation, application fees, security deposits, certified checks and bonding requirements; and

WHEREAS, the work to create the network will require underground and aerial work, and those too come with unique permitting and payment requirements; and

WHEREAS, per consultation with the County's Attorney, contracts may need to be created and signed by the Chairwoman of the Legislature for some towns and villages; and

WHEREAS, more standard boiler plate forms used by several towns and villages will not require review by the County Attorney or a signature from the Chairwoman of the Legislature;

NOW, THEREFORE, BE IT RESOLVED, that Chairwoman of the Legislature is authorized to sign any paperwork required by a local government in respect to a local work permit; and be it further

RESOLVED, that any fees incurred for said permitting, either temporary (bonding, security deposits, etc) or non-refundable fees (application fees, bonding creation fees, etc) be paid by the County and charged against the ReConnect grant at the soonest possible time; and

RESOLVED, that copies of this resolution be provided to the County Administrator, the County Planner, the County Attorney, and the Broadband Project Manager. VOTE: Unanimous
