Local Law No. 3 of the year 1976.

A local law authorizing the County of Yates to participate in the Western Regional Off-Track Betting Corporation for the conduct and operation of Off-Track Pari-Mutual betting on horse races. Pursuant to Chapter 346 of the Laws of 1973 of the State of New York.

Section 1. The County of Yates hereby elects to and shall participate in the Western Regional Off-Track Betting Corporation, a public benefit corporation established by the State of New York by Chapter 346 of the Laws of 1973 of the State of New York. The County of Yates elects to participate in the management and revenues of the Western Regional Off-Track Betting Corporation to permit the County to derive income from off-track betting and for the purpose of assisting enforcement of laws prohibiting illegal gambling.

Section 2. A betting parlor shall not be established in Yates County.

Section 3. This Local Law will take effect on the date it is duly filed in the office of the Secretary of the State of New York and in accordance with the provisions of the Municipal Home Rule Laws of the State of New York.
