SECTION 1: Local Law No. 1 of the Year 1956 of this county, entitled, "A Local Law Establishing a Plan of Self-Insurance as Provided for in Article 5 of the Workmen's Compensation Law, and Providing for the Administration Thereof", is hereby amended to read as follows:

SECTION 11. A self-insurance reserve for the Plan is hereby established. The maximum amount which may be contributed to such reserve shall be \$50,000.

SECTION 2: This Local Law shall take effect on January 1, 1962.
